## REQUEST FOR EXPRESSIONS OF INTEREST (CONSULTING SERVICES – SELECTION OF FIRMS)

REPUBLIC OF URUGUAY

**Call to Consulting Firms to submit Expressions of Interest to be part of a Shortlist to perform the Consultancy “Technology update of the OODO CORE VERTICAL ESTADO URUGUAY product from the baseline version Odoo v8 to the Odoo Community v12 version”.**

The Government of the Republic of Uruguay has received financing from the Interamerican Development Bank for the “Budget and Financial Management Program”, and the Ministry of Economy and Finance will use some of those funds to finance the procurement of consulting services.

The Ministry of Economy and Finance (MEF) hereby invites the eligible consulting firms to express their interest in providing the requested services. The interested consulting firms shall provide information indicating that they are qualified to render such services.

The outcome of this consultancy shall be **“Technology update of the OODO CORE VERTICAL ESTADO URUGUAY product from the baseline version Odoo v8 to the Odoo Community v12 version”**.

### **Main Goal:**

The main goal of the call is the procurement of consulting services for the technological update of the management software ***ODOO CORE VERTICAL ESTADO URUGUAY*** (GRP Uruguay) from baseline version Odoo v8.0 to version Odoo Community v12.

### **Specific Aims of the Consultancy:**

It is expected that the consultants have a very good knowledge of the baseline versions of Odoo and sufficient functional knowledge about the product ***ODOO CORE VERTICAL ESTADO URUGUAY*** to allow them to update this source code from its baseline version Odoo v8 to version Odoo Community v12 by making the necessary changes so as to respect and ensure both the compatibility with the new version Odoo v12 and the quality of the product, as well as the preservation of 100% of its functionality. The main activities to perform during the consultancy are:

### **Analysis of the Migration Requirements and Definition of the Strategy**

The goal of this activity is to carry out a comprehensive analysis of the current code of the ***ODOO CORE VERTICAL ESTADO URUGUAY*** in order to determine all the necessary changes on the current product in order to comply with:

1. Adapting it from a baseline version of Odoo v8 to an Odoo Community v12 version using all the possibilities and features offered by the latter.<sup>1</sup>

<sup>1</sup> A technological upgrade of the product is considered, but without migrating the deployments from previous versions, i.e. the upgrade should be compatible with the data of current v8.0 deployments.

2. Making all necessary changes so that the architecture and code of *ODOO CORE VERTICAL ESTADO URUGUAY* complies with the Quality Standards of both the OCA and the Uruguayan Government<sup>2</sup>.
3. Correcting functional weaknesses already identified in version 8.0 (e.g.: setting up accounting entries with some level of parameterization, improving the security system, identifying transactions at the level of executing units and offices)

- **Product Migration**

1. Delivering an operational version with 100% of the current functionality of *THE OODOO CORE VERTICAL ESTADO URUGUAY* based on Odoo Community v12.
2. Delivering a version of the *Odoo CORE Vertical Estado Uruguay* product that has passed the quality tests determined by the OCA as acceptable and all of the quality standards required by the Uruguayan Government as well as all the products associated with the development and subsequent deployment of this solution.

- **Deployment of a Test Prototype and Validation**

1. Deploying, updating, and configuring a test environment to validate the new version of the solution.
2. Making the necessary adjustments so that the solution can be validated (bug fixes, improvements, or redesigns)

**THE CRITERIA FOR THE SELECTION OF THE SHORTLIST ARE AS FOLLOWS:**

- 1) **Company background.** This background shall be submitted in ANNEX I (pages 5-7) indicating the requested information for each project. Additionally, this information shall be elaborated on in a second document, indicating in detail the activities carried out and any other information deemed important, identifying the projects with the same number (Field "#") in both documents, to allow them to be easily identified and related. The format of ANNEX I is detailed in this document (pages 5-7).

A maximum of 20 projects developed within the last 5 years shall be assessed, where the following shall be evaluated:

- OODOO Partner and member or contributor of the OCA.
- Verifiable experience in the development of Odoo customizations (preferable in Odoo ERP modules and in versions 8 - 12).
- Verifiable experience in Odoo deployments (the experience with Odoo ERP modules and versions 8 – 12 shall be especially valued).
- Verifiable experience in projects with public or government entities (Odoo projects and those with Latin American countries shall be especially valued).
- Verifiable experience in Odoo version migration projects (those made from version 8 to 12, as well as Odoo customizations similar to the work requested shall be especially valued).
- Verifiable experience in the development and/or deployments of the *ODOO CORE VERTICAL ESTADO URUGUAY* product.

Additionally, a note (signed by the legal representative of the company) declaring to be empowered to exercise trade acts, with the following information, shall be submitted:

- a. Nationality (in case of being Uruguayan, it shall be a commercial company constituted in the country, under any of the company types established in the Code of Commerce, in Law 16,060 of September 5, 1989 and related regulations).

- b. Address.
- c. Phone number and e-mail address.
- d. Company name and RUT ("Single Tax Registration" for Uruguayan firms or its equivalent for foreign companies).

**The consulting firms may partner with other companies under the form of Participation in Partnership, Consortium or Association (APCA in Spanish), with the purpose of improving their qualifications. The consulting firms selected to integrate the Short List must register with the RUPE (Sole Registry for Government Providers), in order to be able to enter into contracts with this Ministry<sup>3</sup>.**

**It is the responsibility of the firm to warrant that its experts, the members of the Association or Joint venture (Participation in Partnership, Consortium or Association), sub consultants, agents (whether declared or not), service providers, suppliers and/or employees comply with the eligibility requirements.**

**This instance of the process does not require the submission of information related to the human resources of the consulting firms, nor on a methodology or working plan. The information submitted relating to these matters shall not be taken into consideration.**

This call is focused on the hiring of a consulting firm, using the procedure of **Quality and Cost Based Selection (QCBS)**, pursuant to Section II (2.1 to 2.30) of the Policies for the Selection and Contracting of Consultants Financed by the Inter-American Development Bank (GN-2350-9). This requires pre-qualifying within a short list of 6 firms interested in submitting the respective offers.

The expressions of interest shall be submitted to "**Unidad Coordinadora de Proyectos, Sector Adquisiciones**", Colonia 1089 Planta Baja (personally or by mail), or by e-mail to [ucp.llamados@mef.gub.uy](mailto:ucp.llamados@mef.gub.uy), at the latest by **October 17, 2019 at noon**. In case of submitting them personally or by mail, **a printed original and a copy** (with numbered pages) and **a copy on a magnetic medium of the signed original** (in PDF format) is required. In case of discrepancies between both versions, the printed version shall prevail.
